The object of the trust shall be to establish;








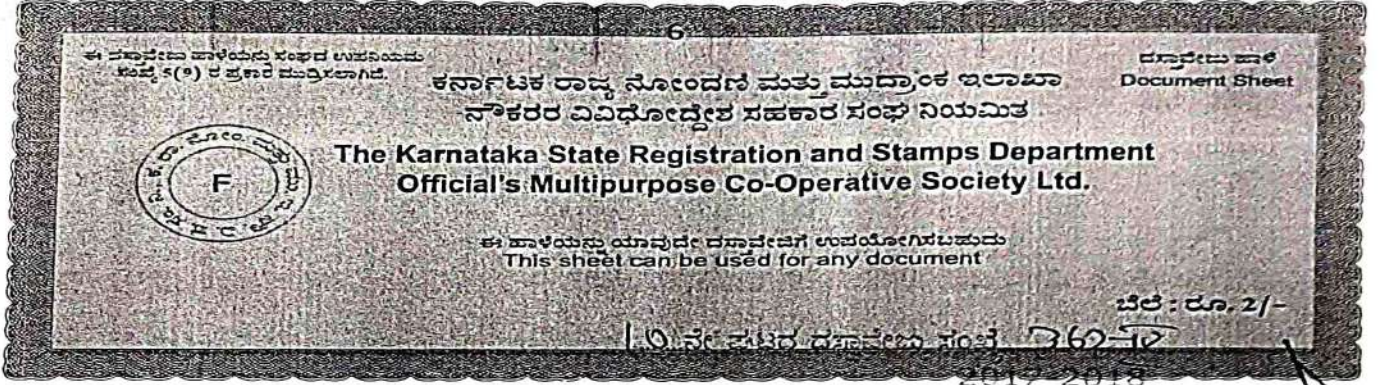

**EXPANSION OF TRUST**

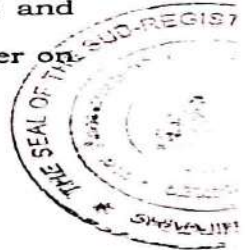
